# RECOGNITION

# **CONSENT AGENDA**

The Board of Education voted unanimously to approve the Consent Agenda. The Consent Agenda consists of items that the Board considers routine and approves under one motion.

### FINANCIAL SERVICES

The School Board reviewed the September Monthly Expenditure Report.

The Board of Education voted unanimously to approve the Maximum Class Size Expectations Waiver: Dr. Blanchard, Director of Human Resources, reported a Maximum Class Size Expectations Wavier was submitted on October 1, 2021, to TEA for Castleberry Elementary Kindergarten and Castleberry Elementary 4th Grade classrooms.

# **TEACHING, LEARNING, AND INNOVATION**

The Board of Education voted unanimously to approve the 2021-2022 District Improvement Plan. The district plan was created with input from the Teaching, Learning, and Innovation Team and the Superintendent's Cabinet.

Elementary Campus Improvement Plans for the 2021-2022 school year were presented to the Board of Education. Principals from A.V. Cato Elementary, Castleberry Elementary, and Joy James Elementary gave a presentation that highlighted a variety of strategies each campus will be working on this school year.

**DEIC/SBDM election results:** Membership for the District Educational Improvement Committee and the campus Site-Based Decision -Making committees were reviewed for the 2021 - 2022 school year.

**Emergency Connectivity Fund Information:** The Technology department has applied for \$303,501.42 in federal funds made available through the FCC's Emergency Connectivity Fund (ECF) in order to supplement our at-home connectivity programs, as well as our students who do not have a device at home adequate for online learning.

**Extended Year PEIMS Report**: The Extended Year PEIMS 2019-2020 submission was completed in August. PEIMS information was listed along with a comparison from prior years.

**Capital Improvements Projects Update (2021-2022)**: The Projects Report reflected work scheduled to be completed and funds expended through the 2021-2022 school year.
