

## **Board of Education Meeting Notes**

# October 5, 2020

### **CONSENT AGENDA**

The Board of Education voted unanimously to approve the Consent Agenda. The Consent Agenda consists of items that the Board considers routine and approves under one motion.

The items approved were:

- 1. Consider Approval of Board Minutes from September 14, 2020, for a Regular Meeting.

- 4. Consider Approval of the **2020 District Appraisal Roll**: The 2020 Supplemental Certified Appraisal Roll Valuation Summary was presented and the values have been certified by the Chief Appraiser.

#### **TEACHING, LEARNING, AND INNOVATION**

Renee Smith-Faulkner, Associate Superintendent, highlighted key items in the **Castleberry ISD Asynchronous Learning Plan** that was submitted to the Texas Education Agency on September 21, 2020 for approval.

The Board of Education voted unanimously to approve the Castleberry ISD Asynchronous Learning Plan: The district plan was created with input from the Teaching, Learning, and Innovation Team.

**Elementary Campus Improvement Plans for the 2020-2021 school year were presented to the Board of Education.** Principals from A.V. Cato Elementary, Castleberry Elementary, and Joy James Elementary gave a presentation that highlighted a variety of strategies each campus will be working on this school year.

**DEIC/SBDM election results**: Membership for the District Educational Improvement Committee and the campus Site-Based Decision -Making committee was shared for the 2020-2021 school year.
