### PRESENTATIONS TO THE BOARD

Derrick York, of WRA Architects, delivered a **Facilities Planning** update to share the progress made toward the potential remodel and new construction project for Castleberry High School, which is contingent upon the upcoming Bond Election in May.

Key aspects such as design concepts, proposed timelines, and solutions to challenges identified during the facilities committee meeting and the overall planning phase with district personnel were discussed.
