The District Annual Report

Texas Education Code (TEC) Chapter 39.306 requires each district's Board of Trustees to publish an annual report that includes the following:

- Texas Academic Performance Report (TAPR)
- District accreditation status
- Special education determination status
- PEIMS Financial Standard Reports of 2019-2020 Actual Financial Data
- Campus performance objectives
- A report of violent or criminal incidents
- Information received under Texas Education Code §51.403(e) from the Texas Higher Education Coordinating Board

The Board of Trustees shall hold a hearing for public discussion of the report, and they shall widely disseminate the report within the district.



Texas Academic Performance Report (TAPR)

The TAPR comprises the main part of the district's annual report.

TAPR Comprehensive Glossary and the district TAPR have been downloaded and included as an exhibit to this agenda item for Board and public review.

The TAPR is a compilation of reports on student achievement presented to the Board throughout the school year which includes:

- STAAR/EOC Assessment Results
- Accountability Reports
- Student Attendance Information
- Drop-Out/Graduation Rates
- College, Career/Military Ready Graduates
- TSIA, AP/IB Results
- SAT/ACT Results

- The financial section of the TAPR for the district and each campus is provided by the State Funding Division of the Texas Education Agency (TEA).

- The district's PEIMS Financial Standard Report of 2019-2020 Actual Financial Data has been downloaded and included as an exhibit to this agenda item for Board and public review.



Campus Performance Objectives

- *TEC §11.253* requires that each campus improvement plan set objectives based on the TAPR and periodically measure progress toward the performance objectives.
- Campus improvement plan goals and objectives are reviewed and presented to the Board four times per year.



Report on Violent or Criminal Incidents

- *TEC §39.306* requires every district to publish a report on violent or criminal incidents at their campuses in the annual report.
- The Castleberry ISD 2020-2021 Report on Violent or Criminal Incidents is included as an exhibit for Board and public review.



Student Performance in Postsecondary Institutions

- *TEC §51.403(e)* requires postsecondary institutions in Texas to report student performance during the first year of enrollment after high school graduation to the high school from which students graduated. Districts must include this information in the annual report.
- The most current report is titled *Report of 2018-2019 High School Graduates Enrollment and Academic Performance in Texas Public Higher Education*.

Reporting Requirements

Public Hearing

- Notice of Public Hearing
- Posted on District website
- Posted on District social media sites

Dissemination of the TAPR: Within two weeks after the hearing, the TAPR must be widely disseminated within the district.

- District and Campus websites
- Notification through e-mail to parents

2020-2021 School Report Cards (SRC) should be released the end of January 2022. These will be posted on campus websites and parents will be notified through e-mail.
